Aquashadow® Lake and Pond Colorant is a concentrated dye formulation packaged in convenient pouches. The water-soluble pouch dissolves and the water either colored a blue or reflective black to beautify off-colored or murky water. Just toss the pouches in your pond.

For use in lakes, ponds, decorative features and other impounded bodies of water with limited outflow. Great for golf courses to aesthetically conceal underwater equipment.

### FIRST AID

**WATER USE RESTRICTIONS:** Allow several hours for product to disperse before swimming, irrigating, or fishing. Do not apply directly to drinking water sources. When used at recommended dosage rate, treated water will not stain exposed surfaces. When used at recommended dosage rate, treated water will not harm fish, waterfowl, pets or wildlife.

**DIRECTIONS FOR USE:**

- Determine water volume (acre-feet or cubic meters) as follows:
  - Length (ft.) x Width (ft.) x Average Depth (ft.)/43,560 = Acre-Ft
    - Note: One Acre-ft = 326,000 gal. = 1,234m<sup>3</sup>
- Use one 4.3 oz. pouches for each acre-ft of water as determined in #1 above.
- Remove pouches from packaging with a dry, gloved hand. Apply by gently tossing pouch into the water body. If multiple pouches are needed, space evenly around the water body.
- Pouches dissolve within several minutes, releasing product. Complete, even dispersion will occur within hours after treatment, depending upon water movement.
- As needed, add pouches to maintain desired color effect following dilution or water exchange.
- Do not handle pouches with wet hands or gloves or place on wet surfaces. Chlorine or oxidizers will cause this product to fade.

**STORAGE & DISPOSAL:** Store in cool place in closed container. Do not freeze. Freezing may cause pouch film to become brittle. Keep pouches in original packaging until ready for use. Offer pails for recycling or dispose of according to state and local regulations. In case of spill, sweep up dry material carefully, wipe up excess with rags, and dispose of properly.
