DIRECTIONS FOR USE

FOR USE WITH PRODUCTS REGISTERED FOR: AGRICULTURE, AQUATIC, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, ORNAMENTAL, RIGHTS-OF-WAY AND TURF.

The addition of additives to some pesticides, fertilizers, and tank mixes may cause phytotoxicity to the foliage and/or fruit of susceptible plants. Prior to the addition of SePRO MSO to fertilizers and pesticides where the addition of surfactants is not specifically recommended but not prohibited by the manufacturer, the user or application advisor must have experience with the combination or must have conducted a phytotoxicity trial.

Fill spray tank ½ full with water and begin agitation. Add pesticides as directed by label, while maintaining agitation. After pesticides are thoroughly mixed, add this product at recommended rate. Some pesticides have stated adjuvant use rates. In all cases, the pesticide manufacturer's label should be consulted regarding specific adjuvant use recommendations and that rate should be followed. Do not add adjuvant at a level that would exceed 5% of the finished spray volume.

For ground applications of SePRO MSO with ground applied pesticides, use 1-4 pints per acre in 5-30 gallons of spray.

For aerial applications of SePRO MSO, use 6 -16 oz/acre. A minimum of 1.0% by volume is recommended for aerial and low volume spray applications.

CAUTION: Do not mix oxidizing agents unless oxidizing agents are in solution.
