## DIRECTIONS FOR USE

For use in lakes, ponds, water hazards and irrigation tanks.

Apply from Spring through Autumn, or any time of the day when water temperature exceeds 50°F.

Muck-Klear works effectively in a broad range of water pH between 5.5 and 8.5.

Wear proper safety equipment including rubber gloves and eye protection when handling or applying product.

**Determine the amount of product required, using the calculations and charts below.**

**Surface Acres: Length (ft.) x Width (ft.) / 43,560 = Surface Acres**

Start-up Applications (Pounds per Surface Acre)	Maintenance Application (Pounds per <b>Surface Acre</b> )
20 Pounds	10 Pounds

**Square feet : Length (ft) x Width (ft) = Total Square Feet**

Start-up Applications (Pounds per 1000 square feet)	Maintenance Application (Pounds per 1000 Square Feet)
.5 Pounds	.25 Pounds

**Application:** Spread pellets evenly like grass seed over muck bed using a scoop, handheld fertilizer spreader, or mechanical-type spreader.

**Start-up Applications:** Apply specified dose every 14 days until desired level of muck reduction is achieved. Repeat Start-up Applications until muck levels are reduced then proceed with Maintenance Applications.

**Maintenance Applications:** Apply specified application rate every 30 days to maintain desired appearance to digest muck seasonally.
